Measurements

We will use the EOY Acadience results from each year to determine typical growth (pathways of progress) and proficiency.

Action Plan Steps

- 1. Instruction will be assessment driven using benchmarks, running records, ACADIENCE data, Rise data, etc.
- 2. Technicians will be hired to provide interventions for readers that are below grade level.
- 3. Take-home and leveled libraries will be improved to provide on-level books for independent and guided practice. A technician will be hired to maintain these libraries.
- 4. Students will track their reading growth in their leadership binders and school wide and classroom incentives will be provided if students reach their reading goals.

Behavioral/Character Education/Leadership Component	We are a Leader In Me school and as such there is a big focus on making goals and tracking progress. Each student makes a reading goal based on their own reading levels, and we track them as individual students, as classes, and as a whole school. Additionally, we have a PBIS structure in place that students earn Croc Cash for living the habits. They can then use the Croc Cash to purchase items from their teacher, or the office. Money will be used to purchase the items used as incentives as they reach their goals.
